## **Easley Combined Utilities**

There will be four (4) \$500 scholarships offered to eligible candidates. To be eligible for an Easley Combined Utilities (ECU) scholarship, an applicant's parent or legal guardian must be on ECU's electric service from the time of application through graduation. This scholarship is granted only to high school seniors graduating in the spring of 2025. The recipient(s) of the scholarship must attend a four-year college/university, community college, and/or technical school within the state of South Carolina.

The application, and all attachments, must be signed, completed and submitted to ECU at c/o Tripp Martin, P.O. Box 619, Easley, S.C. 29641. If an applicant fails to complete the entire application or fails to submit all the items in the format requested by the deadline date, the application will be withdrawn.

Please note that the application must be signed by both the applicant and a parent/legal guardian of the applicant.

**The application deadline is February 28, 2025.**

By submitting the application package and the required attachments and submissions related to the application, the applicant and his or her parent/legal guardian signing the application are certifying that the information submitted is true and correct to the best of their knowledge and the applicant and his or her parent/legal guardian are agreeing to the scholarship conditions set forth below.

## **Scholarship Conditions**

The terms and conditions on which the scholarships are to be awarded for the 2025 scholarship year are as follows:

1. The scholarships will only be awarded to seniors graduating in the spring of 2025.
2. The applicant's parent or legal guardian must be on ECU's electric service at the time of application through graduation.

3. The applicant must attend a four-year college/university, community college, or vocational school in the state of South Carolina.
4. The applicant must complete an Energy Audit\* of his or her residence and attach the “Energy Advisor Report” report to the application.
5. The applicant must write a brief summary of the report, discussing the findings and attaching it to the application.
6. The applicant must attach his or her official high school transcript to the application.
7. The scholarship recipient will be paid via check upon providing evidence of enrollment in an educational institution within the state of South Carolina.
8. The scholarship will be announced and awarded in the spring of 2025 prior to graduation.
9. The recipient(s) will receive a certificate from ECU in recognition of their award on awards night.
